# SECOND AMENDMENT TO DECLARATION OF COVENANTS AND RESTRICTIONS FOR VILLAGES OF VALENCIA

THIS SECOND AMENDMENT ("Second Amendment") is made effective this day of vectors, 2011, by VALENCIA ST. AUGUSTINE, LLC, a Florida limited liability company (the "Declarant") and joined by VILLAGES OF VALENCIA HOMEOWNERS ASSOCIATION, INC., a Florida corporation not for profit (the "Association").

#### **RECITALS:**

- A. The Declaration of Covenants and Restrictions for Villages of Valencia has previously been recorded in Official Records Book 2953, at page 441, as amended by that Supplemental Declaration and Amendment to Declaration of Covenants and Restrictions For Villages of Valencia recorded in Official Records Book 3455, Page 425, all of the public records of St. Johns County, Florida (the "Declaration").
- B. Woodside Valencia, LLC, a Florida limited liability company "Woodside") assigned to Declarant all of Woodside's rights as "Declarant" under the Declaration, pursuant to that certain Assignment of Developer's Rights recorded in Official Records Book 3438, Page 1147 of the public records of St. Johns County, Florida.
- C. Pursuant to Developer's right to amend as set forth in Article XI, Section 25(f) of the Declaration, the undersigned hereby amend the Declaration as more particularly set forth herein.

## NOW THEREFORE, the parties hereby further amend the Declaration as follows:

- 1. The Declaration is hereby amended to add to Article VII, Section 1 a new subsection (5) as follows:
- (5) Lots sold by the Developer to a builder (not an individual) for the construction of a home and subsequent resale of such home and Lot to a homeowner shall also be exempt from the Assessments created herein for a period not to exceed 1 year from the date of such sale by the Developer to the builder, however such Lots shall be subject to a one time Initial Builder Assessment of \$300.00 for Townhome Lots and \$400.00 for Single Family Lots, which assessment shall be due upon transfer of the Lot from the Developer to the builder and which assessment may be used by the Association for either operating or capital expenses.
- 2. All other terms and provisions of the Declaration not affected hereby shall remain in full force and effect.
