Motion amended to read: Have President DePallo hold an Executive Session meeting with Leland Management leadership within TWO weeks to further discussions toward an amicable contract termination. John Hart to prepare a consolidated list of Board and homeowner issues for the board to present at the meeting. Meeting is to be held at the Riverview Club.
